

Lindsey Wilson University Annual Security/Fire Safety Report

Introduction

The Department of Public Safety and Security is a division of the Office of Student Services, its mission is to work in partnership with the campus community through a continuing commitment to safety and education. The department is committed to protecting the lives and property of the campus community. As part of the larger campus community, the department strives to foster an environment where diversity is celebrated; citizens of all races, creeds, religions, and nationalities are made welcome and their rights are preserved.

The Department of Public Safety and Security is responsible for assisting in the enforcement of Federal and State laws through its authority established by Kentucky State Law as revised and as directed by Lindsey Wilson administration for all safety/security and other emergency responses as may be deemed necessary on the campus.

The Department of Public Safety and Security receives support from and has regular communication with the Kentucky State Police, Columbia Police Department, Adair County Sheriff's Department, the Columbia Fire Department, Adair County Emergency Management, and emergency medical services for any necessary responses to the campus. In addition, local law enforcement authorities operate, or may operate random patrols at their discretion in response to jurisdictional authority under state law.

The Department of Public Safety and Security is available 24 hours each day, year round, including holidays and campus closings. The office is located in the Cralle Student Union Building. All students, employees, and guests of Lindsey Wilson should assist the Department of Public Safety and Security in maintaining a safe campus environment by reporting any unusual or suspicious behavior. The Department of Public Safety and Security is available to assist students, employees, and guests of Lindsey Wilson for any reason. If you need assistance, please dial 270-384-8106. Reporting Crimes and Emergencies

A crime or emergency can be reported at any time. All crimes and emergencies can be reported to the Department of Public Safety and Security by dialing 270-384-8106. Additionally, you can call/text to 270-634-1147, or email at security@lindsey.edu, or by visiting the office located in the Cralle Student Union Building. All students, employees, and guests of the

University are encouraged to voluntarily report all crimes to Public Safety (270-384-8106 or call/text 270-634-1147), or the Columbia Police Department (dial 911 or 270-384-4119) with the understanding that confidentiality will be respected at all times. Those crimes that are covered in the Clery Act will be included in the Lindsey Wilson annual crime statistics report. Public Safety will call for assistance from the Columbia Police Department in situations involving incidents where sworn law enforcement is necessary. Lindsey Wilson may handle some incidents administratively depending on the nature of the situation.

The Department of Public Safety and Security prepares the annual security and fire report to comply with the Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act. This report includes campus crime and arrest statistics reported to the Department of Public Safety and Security, designated campus officials and the Columbia Police Department. Bi-annually, an e-mail notification is sent to all enrolled students, faculty, and staff. This email serves to provide the web address to access the Annual Security and Fire Safety Report. Copies of the report may also be obtained at the Department of Public Safety and Security located in the Cralle Student Union Building.

It is everyone's responsibility to help assure the safety and security of every student, employee, and visitor to the Lindsey Wilson community. To that end, if you witness a crime, event, or have any information that needs to be communicated please do so.

Timely Warning Policy

In compliance with the “Timely Warning” provisions of the Federal Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act of 1998, the Office of Student Services in support of the Department of Public Safety and Security will issue a **Timely Warning** via campus e-mail to the Lindsey Wilson community for crimes that may present an ongoing threat to the safety and security of students, faculty and staff. Notifications may also include postings/updates to the Lindsey Wilson home web page, in addition to hard-copy notices posted in campus buildings.

Emergency Notification Policy

In the event of a confirmed campus emergency or an impending event that may present an immediate threat to the safety and security of some or all of the Lindsey Wilson community, the Office of Student Services in support of the Department of Public Safety and Security will activate the Lindsey Wilson **RaiderAid** Emergency Notification system (provided by RAVE Mobile Safety).

RaiderAid is the primary and most immediate source for alerts, information, and updates in the event of an emergency. The system is tested throughout the academic year. In the event of an emergency, messages are immediately sent to the entire campus community via RaiderAid SMS text. Additional RaiderAid communication and information updates may include email, and voicemail. Lindsey Wilson will make additional announcements and updates to the home web page and official social media in the event of an emergency or incident.

The RaiderAid alert notification system is a free service available to all students, faculty, and staff. As a member of the Lindsey Wilson campus community, you are automatically

enrolled in the RaiderAid system. You can also sign in to your Lindsey Wilson portal, go to SETTINGS, select OPTIONS, RAIDERAID and update contact information.

Active Shooter/Campus Lockdown

Lockdown is appropriate when an active threat from outside or inside a building poses an imminent danger to students, faculty, staff or guests. These threats could include a violent person(s) attempting to enter a building, a perpetrator already inside, or nearby criminal or terrorist activity. Lockdown procedures are implemented to protect everyone from the potential consequences of the pending threat. Time is critical in such a crisis and the lockdown must be initiated as quickly as possible.

It is extremely important that faculty and staff assist in announcing the lockdown and directing individuals to a room/building that can be secured. Notifications of an emergency lockdown and updates will be through RaiderAid and may also include email, voice mail announcements and official Lindsey Wilson social media. In the event that Lindsey Wilson or the surrounding community experiences an imminent threat that requires a lockdown it is critical to follow the procedures listed below.

Lockdown Procedures

1. Move to the nearest building or room that can be secured. Check outside (i.e., hallways/common areas) for nearby students, faculty, staff or visitors and move them into a secure area.
2. Close and lock all doors and windows.
3. Cover door windows and close window blinds if possible.
4. Turn off room/office lights and remain quiet.
5. Keep mobile phones close but silenced and monitor RaiderAid alerts, Lindsey Wilson social media and official website for updates.
6. If you have relevant information regarding the threat, call 911, identify yourself, your location and provide the information.
 - a. Note: If a lockdown order has been issued, police and campus security already are aware of the threat. Unless you have critical information, try not to tie up communication and monitor your phone for updates.
7. Remain under lockdown until advised by Lindsey Wilson personnel or emergency response personnel.

Run-Hide-Fight

RUN - Getting away from the shooter or shooters is the top priority. Leave your things behind and run away. If safe to do so, warn others nearby. Call 911 when you are safe.

HIDE- If you can't get away safely, find a place to hide. Get out of the shooter's view and stay very quiet. Silence your electronic devices and make sure they won't vibrate. Lock and block doors, close blinds, and turn off the lights. Don't hide in groups - spread out along walls or hide separately to make it more difficult for the shooter. Try to communicate with police silently - like through text messages or by putting a sign in an exterior window. Stay in place until law enforcement or school officials give you the all clear.

FIGHT- Your last resort when you are in immediate danger is to defend yourself. Commit to your actions and act aggressively to stop the shooter.

Crime Prevention and Awareness Programming

Programming and literature published by Lindsey Wilson encourages students and employees to adopt safe behaviors. The objective of the Department of Public Safety and Security is to foster a sense of personal responsibility by the Lindsey Wilson community for everyone's safety and security. Members of the Lindsey Wilson community are encouraged to be alert to suspicious or criminal activity and to accurately and promptly report criminal actions and other emergencies that occur on the campus. Anyone needing assistance or wishing to report a possible crime or emergency should contact the Department of Public Safety and Security.

The Office of Student Services and the Department of Public Safety and Security keep a complete copy of the report for viewing upon request.

The Department of Public Safety and Security and the various divisions of Student Services sponsor year-round programming on crime prevention and safety awareness. Programming includes discussions, on-line training, videos, and presentations by leading experts in the fields of law enforcement, fire, health, and wellness. Presentations and services are made available to student organizations, residential students, and to new students during orientation, as well as employees.

Among the services provided by the Department of Public Safety and Security include, but are not limited to: escorts, handicap and special needs assistance, vehicle assistance, crime reporting and general crime prevention.

Alcohol and Drug Policy

The Federal Drug Free Schools and Communities Act Amendment of 1989 and Federal Drug-free Workplace Act of 1988 require all public and private higher education institutions to develop, distribute, and publicize a policy regarding standards of conduct for drugs and alcohol use. Lindsey Wilson is committed to providing a healthy and safe environment for its students, faculty, staff, and guests by maintaining a drug and alcohol-free campus.

As a recipient of federal grants and funding, and in compliance with federal and state laws, Lindsey Wilson defines below, the standards of conduct in relation to the unlawful possession, use, distribution, or manufacture of alcohol or illicit drugs. Conduct which is volatile of this standard poses unacceptable risks and disregard for the health, safety, and welfare of members of the Lindsey Wilson community and shall result in disciplinary action, including compulsory rehabilitation, suspension, and/or termination.

New and returning students have access to the Student Handbook every year and the Employee Handbook is given to all new hires during employee orientation. The policy regarding drugs and alcohol is clearly outlined. Students, faculty, staff and guests are prohibited from the unlawful possession, use, distribution, or manufacture of illicit drugs and alcohol whether on Lindsey Wilson property, on school business, and/or elsewhere while attending school sponsored activities. Lindsey Wilson maintains a drug and alcohol-free campus for all students, faculty, staff, and guests.

Students, faculty, and staff are required to abide by state and local laws concerning alcoholic beverages. It is unlawful for any individual under the age of 21 to:

1. Possess or consume alcoholic beverages.
2. Misrepresent one's age for the purpose of purchasing alcoholic beverages.
3. Use false identification in an attempt to purchase alcoholic beverages.

No matter what one's age, Kentucky law states that it is unlawful to:

1. Procure any alcoholic beverages for anyone less than 21 years of age.
2. Drink or be drunk in public places (Lindsey Wilson campuses and buildings are considered as public places for purposes of these laws).

Lindsey Wilson offers educational opportunities for the faculty, staff, and students on the risks and consequences of drug and alcohol use through educational videos, programming, featured speakers, and written documentation concerning the use of drugs and alcohol. Lindsey Wilson Human Resources will work closely with any necessary outside agencies to provide information helpful in the prevention and detection of drug and alcohol use and to post notices and provide handouts when available in the prevention and detection of these problems. Lindsey

Wilson will support and encourage faculty in incorporating drug and alcohol education into the curriculum where appropriate.

Lindsey Wilson will consistently enforce the foregoing standards of conduct respecting drugs and alcohol. Students who violate these standards of conduct are subject to disciplinary action from a minimum of a warning to a maximum of suspension in accordance with procedures outlined in the Student Handbook. Violations by employees shall be dealt with by the President's Executive Staff, exclusive of the President, acting as a body, and may include penalties up to and including dismissal. Without limiting the foregoing, sanctions may include rehabilitation.

Alcohol

Consumption of alcoholic beverages, although legal for adults, is a serious and costly societal problem in America. On college campuses across the country, it is a direct and significant cause of death and injury in accidents, it is heavy contributor to academic failure, and it plays a key role in rape and unwanted pregnancy. Lifetime dependency on alcohol with its attendant costs the loss of human potential and can begin on college campuses. Students should be assured that the Lindsey Wilson staff will use every means necessary to curb the use of alcohol.

Lindsey Wilson is committed to establishing an environment free from alcohol use. Responsible students, staff, and faculty join in this effort by establishing high and clear standards of behavior and conduct in campus life, working with students by example and through educational programs, and by providing counseling and sanctions for those who are unwilling or unable to live according to these standards and expectations. The schools position in all matters related to alcoholic consumption and its consequences are to foster personal growth and maturity among students and to curtail the negative and destructive consequences.

Kentucky state law prohibits the possession or consumption of alcoholic beverages by anyone under the age of 21. The majority of Lindsey Wilson students are under the age of 21, and because it is not always possible to determine where alcoholic beverages have been consumed, Lindsey Wilson establishes the following policy related to alcoholic consumption and its consequences. Students shall not possess or consume any alcoholic beverage on campus or at school-sponsored activities and events, wherever held.

Students who choose to ignore or intentionally violate the campus policy on alcohol, particularly as it contributes to disregard for the rights and safety of others and self or leads to damage of personal or school property, will be sanctioned as follows:

1. First-time and less serious incidents may result in required attendance at a series of educational sessions on the nature and consequences of alcohol misuse. These assigned sessions take precedence over other school activities except scheduled classes. In addition, first and less serious incidents may result in a period of probation, educational sanction, possible fines or a community service work sanction as deemed necessary by the Dean of Students or a designee.
2. Repeat incidents and initial incidents of a serious nature, particularly when an alcohol "problem" is suspected, will result in assignment to a longer and more inclusive series of educational sessions or to mandated personal counseling. These assigned sessions take precedence over all other school activities except scheduled classes. In addition, second and more serious incidents may result in a period of probation, possible fines or a community service work sanction as deemed necessary by the Dean of Students or a designee.
3. Habitual, repeated, and continued serious involvement in alcohol-related incidents, and blatant disregard for the assignments and sanctions mentioned above may result in sanctions such as, but not limited to, suspension from the residence halls or from Lindsey Wilson. At any point in a student's relationship with Residence Life and Student Services staff in alcohol-related incidents and infractions, that student may be placed on campus probation. Formal notice of probation, which may include limitations on visitation rights, participation in school activities or events or special contracted restrictions, will clearly indicate those conditions and the period of time it is to be in effect and will be issued from the Office of Student Services.

Drugs

The use of illegal drugs is potentially harmful physically and mentally and will interfere with the user's ability to function adequately in his/her academic and social life. Also, misuse of illegal drugs often impinges upon the social and academic rights of others. Therefore, the use, possession, presence, sale, and/or distribution of illegal drugs (those specified as illegal by federal, state, and local laws) and/or drug paraphernalia on the campus and off campus can lead to disciplinary action and/or criminal action.

Every effort is made to keep drugs off campus and to prevent the distribution or sale of illegal drugs on campus. Prescription drugs should be used in the manner prescribed. They should be kept in their original container. They may not be used or in any way distributed to another person for any reason whatsoever. Any violation may be punishable by law.

Defining Sexual Violence Offences

The Violence Against Women Reauthorization Act (VAWA 2013) and the Campus Sexual Violence Act (SaVE Act 2013) offer additional categories of sexual violence beyond sexual assault that colleges and universities in compliance with the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act (1998) are required to report. According to the United States Department of Education Office of PostSecondary Education these offenses are defined:

- **Sexual Assault** is sexual intercourse or sexual contact with another person by forcible compulsion or without consent. Absence of protest is not consent. Acts of sexual assault include rape, oral or anal intercourse, and other sexual acts not involving intercourse to which participants are not both consenting.
- **Domestic Violence** means a felony or misdemeanor crime of violence committed by a current or former spouse or intimate partner of the victim, a person with whom the victim shares a child in common, a person who is cohabitating with or has cohabitated with the victim as a spouse or intimate partner, a person similarly situated to a spouse of the victim under the domestic or family violence laws of the jurisdiction receiving grant monies (under VAWA), or any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction.
- **Dating Violence** means violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim and where the existence of such a relationship shall be determined based on a consideration of the following factors:
 - The length of the relationship.
 - The type of relationship.
 - The frequency of interaction between the persons involved in the relationship.
- **Stalking** means engaging in a course of conduct directed at a specific person that would cause a person to fear for his or her safety or the safety of others; or suffer substantial emotional distress.

If an incident of sexual assault, domestic violence, dating violence or stalking is reported to a campus safety authority it must be included in the annual security report in compliance with the Jeanne Clery Act. If you are a victim or a witness to one of these crimes, please contact the Office of Public Safety and Security (270-384-8106 or call/text 270-634-1147) or the Columbia Police Department (911).

Preventing and Reporting Sexual Violence Policy

Sexual violence whether committed by a stranger, friend, or steady dating partner, is a criminal offense and subject to prosecution under the law. Sexual violence will not be tolerated at Lindsey Wilson. Students, faculty, staff, and guests are expected to conduct themselves as responsible citizens with the utmost respect for one another. Sexual violence is a serious, punishable crime that violates the Student Code of Conduct and is punishable under the Judicial System/Process.

The crime of sexual assault is defined as sexual intercourse or sexual contact with another person by forcible compulsion or without consent. Absence of protest is not consent. Acts of sexual assault include rape, oral or anal intercourse, and other sexual acts not involving intercourse to which participants are not both consenting.

In addition to being one of the most prevalent violent crimes on college campuses, sexual assault in the form of "acquaintance rape" is also one of the most unrecognized and under-reported crimes. Other serious forms of sexual violence include domestic violence, dating violence and stalking. If you or someone you know is the victim of sexual assault or another form of sexual violence keep the following in mind:

1. Sexual assault, domestic violence, dating violence and stalking is never the victim's fault.
2. Victims understandably find sexual violence upsetting and painful to discuss. However, it is important to report the incident as soon as possible. Victims are encouraged to contact the police regardless of whether they intend to press charges, but it is the victims' option to, or not to, notify and seek assistance from law enforcement and campus authorities. It is important to understand that reporting the incident does not obligate the victim to press charges. Trained crisis intervention personnel and Public Safety and Security Officers are available to assist victims with necessary law enforcement contacts.
3. Victims may file charges under the Judicial System/Process.
4. Seeking medical help is an important step that should be taken as soon as possible.
 - a. Prior to arriving at the emergency room, sexual assault victims should **NOT** shower, bathe, douche, urinate, defecate, or use mouthwash before receiving a medical examination. Doing so can interfere with the collection of medical evidence.
 - b. If the sexual assault victim wishes to change clothes, the removed clothing should be saved in a paper bag and should not be washed.
5. Going to the hospital as a victim of sexual violence does not obligate pressing charges.
6. Victims of sexual violence should consider seeking support from a relative, resident assistant, good friend, or counselor.

Educational programming on sexual violence prevention is available to all residence halls students. All freshman residential students participate in programming focused on all forms of sexual violence, personal safety, and other relevant topics during opening weekend orientation. Additional programming is conducted by special interest groups and organizations yearly. Adanta Sexual Assault Resource Center (ASARC) advocates provide educational programming and informational resources monthly and offer volunteer opportunity to expand student and employee awareness and prevention. All residential professional staff, including resident assistants, and including the Department of Public Safety and Security receive training for sexual violence.

The Green Dot program at LWU focuses on fostering a culture that power based personal violence is not acceptable and everyone is expected to do their part to help ensure that every member of the Lindsey Wilson campus community is safe and able to thrive. Through educational programming, students, faculty and staff learn to recognize the warning signs for sexual assault, partner violence, and stalking. The bystander training and education fosters a campus community that recognizes how our words, choices, and actions at any given time can change the environment.

If a student is a victim of sexual assault/violence he/she is advised to follow these procedures:

1. Immediately seek a safe place.

A report of sexual violence is a serious allegation, and Lindsey Wilson will offer the accuser and the accused every resource available. In compliance with the Lindsey Wilson Student Handbook, the Student Code of Conduct and Judicial System and Review the Dean of Students or a designee will review a case. Upon completion of a judicial review, possible levels of disciplinary sanctions may include but are not limited to:

1. Warning or Reprimand.
2. Community Service and/or Educational Sanction.
3. Restricted Privileges or use of Facilities.
4. Restitution/Fines.
5. Disciplinary Probation.
6. Counseling Referral.
7. Probationary Reporting.
8. Disciplinary Suspension.
9. Disciplinary Expulsion.

Lindsey Wilson, in compliance with the Federal Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act of 1998, support victims of sexual violence by providing:

- Confidentiality and professionalism, at all times.
- Reasonable options for a change of academic and/or campus controlled residential living situation upon request.
- Judicial no-contact restraining protective orders.
- Both the accuser and the accused have the opportunity for others to be present during any disciplinary hearing in accordance with the Judicial System/Process as outlined in the Student Handbook.
- Both the accuser and the accused learn the outcome of any judicial proceedings “simultaneously” in writing regarding a sexual violence violation.

Stop Campus Hazing Act Policy

Lindsey Wilson University in compliance with the Stop Campus Hazing Act is committed to fostering a safe and healthy campus environment free from hazing. The practice of hazing for the purpose of initiation into any recognized or non-recognized campus team or organization above the reasonable risk encountered in the course of participation in that activity (such as the physical preparation necessary for participation in an athletic team), or physical or psychological injury is prohibited.

Hazing includes, but is not limited to:

- whipping, beating, striking, electronic shocking, placing of a harmful substance on someone's body, or similar activity;
- causing, coercing, or otherwise inducing sleep deprivation, exposure to the elements, confinement in a small space, extreme calisthenics, or other similar activity;
- causing, coercing, or otherwise inducing another person to consume food, liquid, alcohol, drugs, or other substances;
- causing, coercing, or otherwise inducing another person to perform sexual acts;
- any activity that places another person in reasonable fear of bodily harm through the use of threatening words or conduct;
- any activity against another person that includes a criminal violation of local, State, Tribal, or Federal law; and
- any activity that induces, causes, or requires another person to perform a duty or task that involves a criminal violation of local, State, Tribal, or Federal law.

Any member of our campus community who experiences, witnesses, or has knowledge of hazing is encouraged to report it immediately. Lindsey Wilson will investigate all reported hazing incidents thoroughly and take appropriate disciplinary action in accordance with our Student Conduct Conduct. Prevention and awareness programs for campus hazing are available to all students, faculty and staff. Programming focuses on critical issues, including but not limited to campus hazing, prevention strategies, and reporting to campus officials.

Missing Student Policy

In compliance with the Higher Education Opportunity Act Missing Student Notification Policy and Procedures, it is the policy of Lindsey Wilson to actively investigate any report made to a school official concerning a missing resident student. A Lindsey Wilson student may be considered to be a “missing person” if the student’s absence from campus housing is contrary to his/her usual pattern of behavior or if it is known that unusual circumstances caused their absence.

Upon receiving notification, school personnel will make reasonable efforts to locate a missing student. As part of the investigation, Lindsey Wilson reserves the right to communicate with a student’s emergency contacts to determine the whereabouts of the resident. If, upon

investigation, the resident student has been determined to be missing for at least 24 hours, the following will occur:

1. Lindsey Wilson personnel will contact the appropriate law enforcement agency.
2. Lindsey Wilson personnel will attempt to notify the resident's designated emergency contact person.
3. If the student is under 18 years of age, school personnel will contact the custodial parent or legal guardian.

Sex Offender Registration Policy

In compliance with the Campus Sex Crimes Prevention Act of 2000, the Department of Public Safety and Security is providing a link to the Kentucky State Police Sex Offender Registry. The act requires higher education institutions to issue a statement advising the campus community where information provided by the state concerning registered sex offenders may be obtained. It also requires sex offenders already registered in a state to provide notice to each institution of higher education in that state at which the person is employed, carries a vocation, or is a student. Fire Evacuation Procedures

In the event of a fire within a school facility, proceed according to the following plan:

1. Leave the facility by the nearest exit.
2. Sound the appropriate fire alarm or warning system in that area upon exit; confine the fire by closing adjacent doors to the area involved.
3. Contact 911 for the Adair County Fire Department.
4. Contact Public Safety, 270-384-8106 or call/text 270-634-1147.
5. Evacuate all occupants of the building at once. Make sure everyone is at least 500 feet away from the building.
6. Do not restrict emergency vehicles; allow a clear path to the building.
7. Contact Student Services Office, 270-384-8036.
8. Contact Director of Physical Plant Operations, 270-384-8099.
9. Do not return to the building until it is declared safe by fire and school officials

Daily Campus Crime and Fire Logs

In compliance with the Jeanne Clery Disclosure of Campus Security and Campus Crime Statistics Act, the Department of Public Safety and Security maintains a daily crime and fire log. Events are recorded within 48 hours or two business days after an incident. The Daily Crime and Fire Log is available for viewing in the Department of Public Safety and Security office located in the Cralle Student Union Building.

The statistics listed in table format consist of reported crimes during the last three calendar years occurring in the following geographical areas: on-campus, on-campus student housing, non-campus property and public property. For reporting purposes, the following definitions describe these areas:

- **On-Campus**: (1) Any building or property owned or controlled by an institution within the same reasonably contiguous geographic area and used by the institution in direct support of, or in a manner related to, the institution's educational purposes, including residence halls; and (2) Any building or property that is within or reasonably contiguous to paragraph (1) of this definition, that is owned by the institution but controlled by another person, is frequently used by students, and supports institutional purposes.
- **On-Campus Student Housing Facility**: Any student housing facility that is owned or controlled by the institution, or is located on property that is owned or controlled by the institution, and is within the reasonably contiguous geographic area that makes up the campus.
- **Non-Campus Property**: (1) Any building or property owned or controlled by a student organization that is officially recognized by the institution; or (2) Any building or property owned or controlled by an institution that is used in direct support of, or in relation to, the institution's educational purposes, is frequently used by students, and is not within the same reasonably contiguous geographic are of the institution.
- **Public Property**: All public property, including thoroughfares, streets, sidewalks, and parking facilities, that is within the campus, or immediately adjacent to and accessible from the campus.
